That's the total amount of three projects Anawim Housing is currently developing along the 6th Avenue and Forest Avenue Corridors. What an exciting time!

The soon-to-be constructed Brickstones at Riverbend development will serve as home to 30 new households and our Legacy Townhome project will add five more. We have seen such amazing support of these projects from the neighborhood, advocates and donors. We remain focused on the heart of where Anawim began in 1987, by continuing to strengthen this neighborhood in Greater Des Moines.

Our Legacy Project will bring new life to 137 existing units in the Anawim portfolio. Each of these units will receive significant capital improvements to the systems and structure of each building along with updated interior amenities and enhanced curb appeal.

We are also very excited to be breaking new ground with the launch of our third party management company: Allterra Property Solutions. Allterra will focus on property management and development opportunities that would otherwise not fall within the primary market emphasis of Anawim. The new brand allows Anawim to keep focus on its mission targets.

As the calendar turns to 2017 stay tuned to see what's next for Anawim Housing. We begin a yearlong celebration of our thirtieth year of work of providing stable homes and strengthening communities.



PROPERTY SOLUTIONS

Meet Allterra.

ANAWIM HOUSING IS EXCITED TO ANNOUNCE THE LAUNCH OF IT'S NEW PROPERTY MANAGEMENT SER-VICE, **ALLTERRA PROPERTY SOLUTIONS**. THE FOCUS OF ALLTERRA WILL BE ON THE MANAGEMENT OF MARKET RATE AND AFFORDABLE APARTMENTS FOR THIRD PARTY OWNERS THROUGHOUT THE DES MOINES METRO AREA. "Creating this new brand will allow Anawim Housing to focus on its core mission of providing affordable housing to families and individuals as well as permanent supportive housing solutions to highly vulnerable populations," said Russ Frazier, President of Anawim Housing.

Allterra Property Solutions will operate separately from Anawim Housing, allowing Allterra the flexibility to develop new client opportunities and completely differentiate itself from Anawim Housing. Allterra has the ability to serve as a development or management partner that can be blended into new and existing partnerships with other area companies.

This new venture will create a diversified revenue stream for Anawim Housing, where additional revenue from Allterra will help to fund the programs and services Anawim provides. This will in turn allow for continued growth and sustainability for Anawim Housing and all of the families served by our organization.

Allterra is already off to a big start after landing three high profile property portfolios. Drake University has hired Allterra Property Solutions to manage Drake Real Estate. Allterra will operate under the name of Drake Real Estate and manage all of their residential and commercial real estate properties. Blackbird Investments has tapped Allterra Property Solutions to manage their 60-unit Wilkens Building project (formerly known as the Younkers Building), along with their 142-unit Fort Des Moines project.

The three projects together will push Allterra's units under management to 325. "We've been very pleased at how this new effort has been received and we are looking forward to adding many other projects," said Frazier.

On October 6, Anawim Housing broke ground on our 30-unit development known as The Brickstones At Riverbend. The project is located at 513 Forest Avenue in Des Moines, on the corner of 6th Avenue and Forest. In March of this year, Anawim Housing was awarded federal affordable housing tax credit funding for this project from the Iowa Finance Authority. This development will consist of 27 affordable housing units, 3 market-rate and will be an urban-style building for those ages 55 and older. The project will provide seniors in Greater Des Moines an affordable, accessible and quality housing option. Construction is set to begin late this fall with an anticipated completion of early summer 2017.


— Legacy Project Update

Anawim Housing's history along 6th Avenue goes back nearly 30 years where we made some initial property investments; many of which were in dilapidated properties and properties with historical significance. Today, we are one step closer to adding five additional homes in this area, which is known as our Legacy Project. The Legacy Project, located at 1511-1521 6th Avenue, is the first building project Anawim intends to build with private Legacy Campaign funds and donations. We intend to make these units at a reasonable rent, so they are no higher than that of our typical affordable housing units at 60% Area Median Income (AMI). We will now be able to serve those individuals who are slightly over the 60% AMI, who still look for a quality and affordable place to live. This project aims to develop and strengthen the Greater Des Moines community and provide affordable housing options as well as a diverse housing stock for the neighborhood. Digging will begin this fall and we look forward to new tenants moving in by next summer.



Anawim Housing was recently awarded the Prairie Meadows Legacy Grant as well as the Wells Fargo Community Development Grant. These funds are directed toward the build of the Legacy Project project.

PLAYGROUND REVITALIZATION

Thanks to a generous donation from Variety – The Children's Charity, and with help from our friends at Housby, Anawim Housing renovated three of its playgrounds this summer. The playgrounds at 1245 6th Avenue, 1635 6th Avenue, and 1179 11th Street all received updates.

Each of the three playgrounds were selected based on their level of need. Most have gone without any renovation since their original install 20+ years ago and were greatly in need of repair. Funding from Variety – The Children's Charity supported the purchase of new playground equipment for each location. New playground updates include: a dragonfly teeter totter, ladybug rider, bubble mirror panel, a picnic table and solo spinner. Housby teamed up with us for a second year in



a row to help with renovations. Their team of dedicated workers spent three workdays making extensive renovations and providing donations to each project.

"I really enjoyed being able to take time away from my desk for a day in order to make a difference in our community! See-

ing the children looking out of the apartment windows to watch us renovate and clean-up their playground, and seeing the absolute joy and excitement on their faces, is what really makes all of the hard work worth it! It was just a bonus that we were all able to have a lot of fun in

the process doing it," said Housby volunteer Morgan Wentland.

The positive impact these playground updates have is evident in the smiles of the kids trying out the new tire swing, finding their reflection in the bubble mirror, or sliding down the new slide.
